This has reference to your online proposal no IA/PB/IND2/27543/2014 dated 8th May, 2015 alongwith project documents including Form I, Terms of References, Pre-feasibility Report, EIAIEMP Report alongwith Public Hearing Report regarding above mentioned project.

The Ministry of Environment, Forest & Climate Change has examined the application. It is noted that proposal is for expansion of Grain Based Distillery from 100 KLPD to 200 KLPD and Cogeneration Power Plant (from 5 MW to 10 MW) at Village Machchana and Sangat Kalan, Tehsil and District Bathinda, Punjab. Total plot area is 141600 m² of which greenbelt will be developed in 89000 m². Cost of project is Rs. 45.10 crore. Out of which, Rs. 7.35 Crore and Rs. 2.75 Crore are earmarked towards capital cost and recurring cost per annum for implementation of environmental management plan. It is reported that no eco-sensitive area such as national park/wildlife sanctuary/biosphere reserves/ reserve forest is located within 10 km distance. Distillery unit will be operated for 330 days in a year. Phase wise daily production of products and by-products from the distillery plant is given below:-

- 3.0 ESP alongwith stack of adequate height will be provided to additional biomass/coal fired boiler (35 TPH) to control particulate emissions. Fresh water requirement from canal water will be increased from 675 m³/day to 1350 m³/day after expansion. Spent wash generation will be 575 m³/day. spent lees generation will be 150 m³/day and MEE condensate will be 395 m³/day from the proposed expansion. Spent wash from grain based distillery will be passed through decanter and concentrated in multi-effect evaporator (MEE). Thick syrup and wet cake will be mixed together to form Distiller's Wet Grains with Soluble (DWGS) to achieve zero discharge. DWGS will be dried to form Distiller's Dry Grains with Soluble (DDGS). Out of total generation of 545 m³/day of condensate generation, 495 m³/day will be directly reused in the liquefaction process. Effluent from spentlees, utilities effluent and evaporator Condensate (50 m³/day) will be treated in effluent treatment plant and recycled/reused in process. No effluent will be discharged outside the plant premises and 'Zero' effluent discharge concept will be followed. DDGS will be sent to cattle feed. Fly ash will be used for brick manufacturing. Spent oil/waste oil will be sent to authorized recyclers/re-processors.
- 4.0 Public hearing/public consultation meeting was conducted on 20th March, 2015.
- 5.0 All cane juice/non-molasses based distillery (>60 KLD) are listed at S.N. 5(g) (ii) under category 'A' and appraised at Central level.
- 6.0 The proposal was considered by the Expert Appraisal Committee (Industry) in its 28th, 46th and 2nd meetings held during 1st -2nd December, 2014, 20th-21st August, 2015 and 16th-17th December, 2015 respectively. The Committee recommended the proposal for environmental clearance. Project Proponent and the EIA Consultant namely Ace Engineers and Consultants, stay order as per Court case No CWP No. 19598 of 2012, have presented EIA / EMP report as per the TOR. EAC has found the EIA / EMP Report and additional information to be satisfactory and in full consonance with the presented TORs. The Committee recommended the proposal for environmental clearance.
- 7.0 Based on the information submitted by the project proponent, the Ministry of Environment and Forests hereby accords environmental clearance to above project under the provisions of EIA Notification dated 14th September 2006, subject to the compliance of the following Specific and General Conditions:

A. Specific Conditions:

- i) Environment clearance accorded is for grain based distillery unit (200 KLPD) only and no molasses based distillery unit shall be operated without prior permission from the Ministry.
- ii) ESP alongwith stack of adequate height shall be provided to additional biomass/coal

fired boiler (35 TPH) to control particulate emission within 50mg/Nm³. At no time, the emission levels should go beyond the prescribed standards. In the event of failure of any pollution control system adopted by the unit, the respective unit shall not be restarted until the control measures are rectified to achieve the desired efficiency.

- In plant, control measures for checking fugitive emissions from all the vulnerable sources shall be provided. Fugitive emissions shall be controlled by providing closed storage, closed handling & conveyance of chemicals/materials, multi-cyclone separator and water sprinkling system. Dust suppression system including water sprinkling system shall be provided at loading and unloading areas to control dust emissions. Fugitive emissions in the work zone environment, product, raw materials storage area etc. shall be regularly monitored and records shall be maintained. The emissions shall conform to the limits imposed by Punjab Pollution Control Board (PPCB).
- iv) Pucca approach road to project site shall be constructed prior to commencing construction activity of the main distillery so as to avoid fugitive emissions.
- v) The gaseous emissions from DG set shall be dispersed through adequate stack height as per CPCB guidelines. Acoustic enclosure shall be provided to the DG sets to mitigate the noise pollution.
- The company shall upload the status of compliance of the stipulated environmental clearance conditions, including results of monitored data on its website and shall update the same periodically. It shall simultaneously be sent to the Regional Office of MOEF, the respective Zonal office of CPCB and the PPCB. The levels of PM_{2.5}, PM₁₀, SO₂, NOx, CO and HC (Methane) in ambient air shall be monitored and displayed at a convenient location near the main gate of the company and at important public places.
- vii) Total fresh water requirement from surface water supply shall not exceed 1350 m3/day for distillery and cogeneration unit after expansion. Water consumption shall be reduced by adopting 3 R's (reduce, reuse and recycle) concept in the process.
- Spent wash generation shall not exceed 6 KI/KI of alcohol. Spent wash shall be treated through decanter and concentrated in multi-effect evaporator (MEE) to form DWGS. DWGS will be sent to dryer to form DOGS. The condensate, spentlees and utilities effluent shall be treated in the ETP comprising tertiary treatment. Treated effluent will be used for make up water of cooling towers and water quality of treated effluent shall meet the norms prescribed by CPCB/SPCB and recycle/reuse.
- No effluent from distillery and co-generation power plant shall be discharged outside the factory premises and 'Zero' effluent discharge concept shall be adopted.
- x) Process effluent/any wastewater shall not be allowed to mix with storm water. Storm water drain shall be passed through guard pond.
- xi) Automatic /online monitoring system (24x7 monitoring devices) for flow measurement and relevant pollutants in the treatment system to be installed. The data to be made available to the respective SPCS and in the Company's website.
- xii) Spent wash shall be stored in the steel tank with maximum capacity for 5 days for emergency situation.
- xiii) Adequate numbers of ground water quality monitoring stations by providing piezometers

around the project area shall be set up. Sampling and trend analysis monitoring must be made on monthly a basis and report submitted to SPCS and this Ministry. The ground water quality monitoring for pH, SOD, COD, Chloride, Sulphate and Total Dissolve Solids shall be monitored and report submitted to the Ministry's Regional Office at Chandigarh and PPCB.

- xiv) No storage of wet cake shall be done at site to avoid odour problem. An additional dryer shall be installed so that at any time wet cake is not sold then wet cake shall be converted into dry cake by operating additional dryer.
- XV) Biomass storage shall be done in such a way that it does not get air borne or fly around due to wind.
- rvi) Fly ash shall be stored separately as per CPCB guidelines so that it shall not adversely affect the air quality, becoming air borne by wind or water regime during rainy season by flowing alongwith the storm water. Direct exposure of workers to fly ash & dust shall be avoided.
- xvii) Fire fighting system shall be as per norms and cover all areas where alcohol is produced, handled and stored. Provision of foam system for fire fighting shall be made to control fire from the alcohol storage tank.
- xviii) Risk Assessment shall be carried to assess the fire and explosion risk due to storage of alcohol and report submitted to the Ministry and its Regional Office at Chandigarh within six months.
- xix) Dedicated Cell with qualified personnel for Environment management should be established to take care of all pollution related activities including monitoring.
- Occupational health surveillance programme shall be undertaken as regular exercise for all the employees. The first aid facilities in the occupational health centre shall be strengthened and the regular medical test records of each employee shall be maintained separately.
- xxi) Dedicated parking facility for loading and unloading of material shall be provided in the factory premises. Unit shall develop and implement good traffic management system for their incoming and outgoing vehicles to avoid congestion on the public road.
- As proposed, green belt over 33 % of the total project area shall be developed within plant premises with at least 10 meter wide green belt on all sides along the periphery of the project area, in downward direction, and along road sides etc. Selection of plant species shall be as per the CPCB guidelines in consultation with the DFO.
- xxiii) All the commitment made regarding issues raised during the Public Hearing/consultation meeting held on 20th March, 2015 shall be satisfactorily implemented and a separate budget for implementing the same shall be allocated and information submitted to the Ministry's Regional Office at Chandigarh.
- xxiv) At least 5 % of the total cost of the project shall be earmarked towards the Enterprise Social Commitment based on locals need as well as public hearing issues and itemwise details along with time bound action plan shall be prepared and submitted to the Ministry's Regional Office at Chandigarh. Implementation of such program shall be ensured accordingly in a time bound manner.

xxv) Provision shall be made for the housing for the construction labour within the site with all necessary infrastructure and facilities such as fuel for cooking, mobile toilets, safe drinking water, medical health care, creche etc. The housing may be in the form of temporary structure to be removed after the completion of the project. All the construction wastes shall be managed so that there is no impact on the surrounding environment.

B. General Conditions:

- The project authorities shall strictly adhere to the stipulations made by the Punjab Pollution Control Board.
- ii. No further expansion or modifications in the plant shall be carried out without prior approval of the Ministry of Environment and Forests. In case of deviations or alterations in the project proposal from those submitted to this Ministry for clearance, a fresh reference shall be made to the Ministry to assess the adequacy of conditions imposed and to add additional environmental protection measures required, if any.
- The locations of ambient air quality monitoring stations shall be decided in consultation with the Punjab Pollution Control Board (PPCB) and it shall be ensured that at least one station is installed in the upwind and downwind direction as well as where maximum ground level concentrations are anticipated.
- The overall noise levels in and around the plant area shall be kept well within the standards by providing noise control measures including acoustic hoods, silencers, enclosures etc. on all sources of noise generation. The ambient noise levels shall conform to the standards prescribed under Environment (Protection) Act, 1986 Rules, 1989 viz. 75 dBA (day time) and 70 dBA (night time).
- v. The Company shall harvest rainwater from the roof-tops of the buildings and storm water drains to recharge the ground water and use the same water for the process activities of the project to conserve fresh water.
- vi. The Company shall obtain Authorization for collection, storage and disposal of hazardous waste under the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008 and its amendment time to time and prior permission from PPCB shall be obtained for disposal of solid / hazardous waste including boiler ash.
- vii. During transfer of materials, spillages shall be avoided and garland drains be constructed to avoid mixing of accidental spillages with domestic wastewater and storm water drains.
- viii. Usage of Personnel Protection Equipments by all employees/ workers shall be ensured.
- Training shall be imparted to all employees on safety and health aspects of chemicals handling. Pre-employment and routine periodical medical examinations for all employees shall be undertaken on regular basis. Training to all employees on handling of chemicals shall be imparted.
- X. The company shall also comply with all the environmental protection measures and safeguards proposed in the project report submitted to the Ministry. All the

- recommendations made in the EINEMP in respect of environmental management, risk mitigation measures and public hearing relating to the project shall be implemented.
- xi. The company shall undertake CSR activities and all relevant measures for improving the socio-economic conditions of the surrounding area.
- xii. The company shall undertake eco-developmental measures including community welfare measures in the project area for the overall improvement of the environment.
- xiii. A separate Environmental Management Cell equipped with full-fledged laboratory facilities shall be set up to carry out the Environmental Management and Monitoring functions.
- As proposed, the company shall earmark sufficient funds toward capital cost and recurring cost per annum to implement the conditions stipulated by the Ministry of Environment and Forests as well as the State Government along with the implementation schedule for all the conditions stipulated herein. The funds so earmarked for environment management! pollution control measures shall not be diverted for any other purpose.
- A copy of the clearance letter shall be sent by the project proponent to concerned Panchayat, ZiiaParisad/Municipal Corporation, Urban local Body and the local NGO, if any, from who suggestions/ representations, if any, were received while processing the proposal.
- The project proponent shall also submit six monthly reports on the status of compliance of the stipulated Environmental Clearance conditions including results of monitored data (both in hard copies as well as bye-mail) to the respective Regional Office of MoEF, the respective Zonal Office of CPCB and the Punjab Pollution Control Board. A copy of Environmental Clearance and six monthly compliance status report shall be posted on the website of the company.
- xvii. The environmental statement for each financial year ending 31 sl March in Form-Vas is mandated shall be submitted to the Punjab Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as amended subsequently, shall also be put on the website of the company along with the status of compliance of environmental clearance conditions and shall also be sent to the Chandigarh Regional Offices of MoEF bye-mail.
- The project proponent shall inform the public that the project has been accorded environmental clearance by the Ministry and copies of the clearance letter are available with the SPCB/Committee and may also be seen at Website of the Ministry at http://envfor.nic.in. This shall be advertised within seven days from the date of issue of the clearance letter, at least in two local newspapers that are widely circulated in the region of which one shall be in the vernacular language of the locality concerned and a copy of the same shall be forwarded to the concerned Regional Office of the Ministry.
- xix. The project authorities shall inform the Regional Office as well as the Ministry, the date of financial closure and final approval of the project by the concerned authorities and the date of start of the project.
- 8.0 The Ministry may revoke or suspend the clearance, if implementation of any of the above conditions is not satisfactory.

- 9.0 The Ministry reserves the right to stipulate additional conditions, if found necessary. The company in a time bound manner will implement these conditions.
- 10.0 The above conditions will be enforced, inter-alia under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Water Pollution) Act, 1981, the Environment (Protection) Act, 1986, Hazardous Waste (Management, Handling and Trans-boundary Movement) Rules, 2008and the Public Liability Insurance Act, 1991 along with their amendments and rules.

The Ministry of Environment, Forest and Climate Change has examined the above proposal for amendment in the environmental clearance granted by the Ministry vide letter dated 8th April, 2016 in favour of M/s BCL Industries and Infrastructure Ltd for their project Expansion of Grain Based Distillery from 100 KLPD to 200 KLPD and Cogeneration Power Plant (from 5 MW to 10 MW) at Village Machchana and Sangat Kalan, Tehsil and District Bathinda (Punjab), to add one product namely Anhydrous Alcohol in the list of product, deletion of condition No. xii i.e. spent wash storage tanks and increase in land area from 141600 sqm to 259484.43 sqm.
- 3. The proposal was considered by the Expert Appraisal Committee (Industry-2) in the Ministry in its meeting held on 29-31 July, 2019. The EAC, after deliberations, recommended for inclusion of 'Anhydrous Alcohol' in the product list and deletion of condition regarding spent wash storage tanks, but with the additional environmental condition as under:
- Prior approval shall be obtained from the Petroleum & Explosives Safety Organization (PESO) for the site and layout plan submitted to this Ministry along with the proposal for EC. In case of any change therein post PESO approval, the proposal shall require fresh appraisal by the sectoral EAC.

The Committee was not agreed for amendment to effect increase in land area.

4. Based on recommendations of the EAC, the Ministry of Environment, Forest and Climate Change hereby accords approval to the proposed amendment in the environmental clearance dated 8th April, 2016, as stated in para 3 above except increase in land area, to the project for 'Expansion of Grain Based Distillery from 100 KLPD to 200 KLPD and Cogeneration Power Plant (from 5 MW to 10 MW)' at Village Machchana and Sangat Kalan, Tehsil and District Bathinda (Punjab)'.

- 2. The Ministry of Environment, Forest and Climate Change has examined the project for Expansion of existing 200 KLPD grain-based distillery unit and cogeneration power plant of 10 MW capacity by installing 200 KLPD grain-based Ethanol Plant (Additional Biofuel production) and additional 10 MW of power cogeneration at the existing location by M/s. BCL Industries Ltd. located at village Machhana and Sangat Kalan, Tehsil and District Bathinda, Punjab.
- **3.** As per the MoEF&CC Notification S.O. 2339(E), dated 16th June, 2021, a special provision in the EIA Notification, 2006-(Schedule 5 (ga), Category B2) is made, wherein for all applications made for Grain based distilleries with Zero Liquid Discharge producing ethanol; solely to be used for Ethanol Blended Petrol Programme of the Government of India shall be considered under B2 Category and appraised at Central Level by Expert Appraisal Committee (EAC) with condition that the project proponent shall file a notarized affidavit that ethanol produced from proposed project shall be used completely for EBP Programme.
- **4.** Standard ToR and public Hearing conduction is not applicable as the project falls under category B2 as per OM dated 2nd March, 2021 & 16th June, 2021. It was informed that no litigation is pending against the project.
- **5.** Ministry has issued the Environmental Clearance earlier vide letter no. F. No. J-11011/348/2014-IA II (I) dated 8th April, 2016 to the existing project of 200 KLPD grain based distillery and 10 MW of cogeneration of power in favour of M/s BCL Industries Ltd.

7. Existing land area is 236000 sq. meters and no additional land area will be used for the proposed expansion. Industry has already developed green belt in an area of 95000 sq. meters which is more than 33 % of total land area. The

estimated project cost is Rs. 140 crores for the proposed project. Total capital cost earmarked towards environmental pollution control measures is Rs. 18.50 crores and recurring cost (operation and maintenance) will be about Rs. 2.75 crores. Total employment generation will be 500 persons as direct and indirect employment due to the proposed expansion. Industry proposes to allocate Rs. 1.05 crores towards corporate environment responsibility.

- **8.** There are no national parks, wildlife sanctuaries, biosphere reserves, Tiger/Elephant reserves, Wildlife corridors etc. within 10 km distance from the project site.
- **9.** Overall water requirement: Total average fresh water consumption for the existing as well as proposed expansion of the industry can be summarized as under;

Water requirements for the proposed expansion project will be $890~\text{m}^3/\text{day}$ or 4.45~KL/KL of alcohol production

Total water requirements after the proposed expansion will be 3125 m³/day. All the fresh water requirements for the existing as well as proposed project will be met from canal water. The industry has already got the permission from Irrigation Department, Punjab for the supply of canal water @ 3500 m³/day.

The industry will generate a total of $1450~\text{m}^3/\text{day}$ of condensates including spent lees from the proposed expansion. Out of this, $840~\text{m}^3/\text{day}$ will be directly used in the process for slurry preparation. Remaining condensates @ $610~\text{m}^3/\text{day}$ will be treated in condensate polishing unit and reused for cooling tower makeup water. Effluent from misc. streams will be $214~\text{m}^3/\text{day}$ which will be treated in ETP and reused for water of green belt within the industrial premises.

10. Power requirements for the proposed expansion will be 15000 KVA and will be met from in house cogeneration power plant. Existing unit has 1 x 1000 KVA D G set to be used as standby during power failure. Stack height to the D G sets has been provided as per PB norms. Existing unit has 2 x 35 TPH biomass/coal fired boilers. Additional 75 TPH biomass/coal fired boiler will be installed. Electrostatic precipitator will be installed as pollution control system to achieve

the statutory limit of 50 mg/Nm³ for the proposed boiler.

11. Details of process emissions generation and its management:

The industry will install dryers for the handling of DWGS for controlling process odours from the factory.

- **12.** Details of certified compliance report submitted by RO; MoEF&CC vide letter no. 5-297/2011-RO(NZ)/557-558 dated 06.09.2021.
- **13.** As per OM dated 16th June, 2021, PP has submitted self-certification in the form of affidavit declaring that the proposed capacity from 200 KLPD to 400 KLPD will be for manufacturing of fuel ethanol only.
- **14.** During deliberations, EAC observed that fresh water requirement is too high. In this regard EAC directed to revise water balance. PP has submitted the revised water balance reducing fresh water consumption for the proposed expansion to 890 KLPD.
- **15.** The proposal was considered by the EAC in its 40th meeting held on 14th 16th September, 2021 in the Ministry, wherein the project proponent and their consultant M/s. Enviro Infra Solutions Pvt. Ltd., presented the case under B2 category. The Committee **recommended** the project for grant of environmental clearance.
- **16.** The EAC, constituted under the provision of the EIA Notification, 2006 and comprising of Experts Members/domain experts in various fields, have examined the proposal submitted by the Project Proponent in desired form along with the EMP report prepared and submitted by the Consultant accredited by the QCI/NABET on behalf of the Project Proponent. The EAC noted that the Project Proponent has given undertaking that the data and information given in the application and enclosures are true to the best of his knowledge and belief and no information has been suppressed in the report. If any part of data/information submitted is found to be false/ misleading at any stage, the project will be rejected and Environmental Clearance given, if any, will be revoked at the risk and cost of the project proponent.
- 17. The Committee noted that the EMP report is in compliance of the PFR. The Committee deliberated on the CER plan and found to be addressing the issues in the study area. The EAC has deliberated the proposal and has made due diligence in the process as notified under the provisions of the EIA Notification, 2006, as amended from time to time and accordingly made the recommendations to the proposal. The Experts Members of the EAC have found the proposal in order and have **recommended** for grant of environmental clearance.
- **18.** The environmental clearance granted to the project/activity is strictly under the provisions of the EIA Notification 2006 and its amendments. It does not tantamount/construe to approvals/consent/ permissions etc. required to be obtained or standards/conditions to be followed under any other Acts/ Rules/ Subordinate legislations, etc., as may be applicable to the project. The project

proponent shall obtain necessary permission as mandated under the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981, as applicable from time to time, from the State Pollution Control Board, prior to construction & operation of the project.

19. Based on the proposal submitted by the project proponent and recommendations of the EAC (Industry-2), Ministry of Environment, Forest and Climate Change hereby accords environmental clearance to the project for Expansion of existing 200 KLPD grain-based distillery unit and cogeneration power plant of 10 MW capacity by installing 200 KLPD grain-based Ethanol Plant (Additional Biofuel production) and additional 10 MW of power cogeneration at the existing location by M/s. BCL Industries Ltd. located at village Machhana and Sangat Kalan, Tehsil and District Bathinda, Punjab, under the provisions of the EIA Notification, 2006, and the amendments therein, subject to compliance of the terms and conditions as under:-

A. Specific Condition:

- (i). As per OM dated 16th June, 2021, project falls in category B2 and the proposed capacity from 200 KLPD to 400 KLPD shall be only be used for fuel ethanol manufacturing as per self-certification in form of an affidavit by the Project Proponent. Provided that subsequently if it is found that the ethanol, produced based on the EC granted as per this dispensation, is not being used completely for EBP Programme, or if ethanol is not being produced, or if the said distillery is not fulfilling the requirements based on which the project has been appraised as category B2 project, the EC shall stand cancelled.
- (ii). The company shall comply with all the environmental protection measures and safeguards proposed in the documents submitted to the Ministry. All the recommendations made in the EIA/EMP in respect of environmental management, and risk mitigation measures relating to the project shall be implemented.
- (iii). The project proponent will treat and reuse the treated water within the factory and no waste or treated water shall be discharged outside the premises.
- (iv). Total fresh water requirement shall not exceed 890 KLPD for the proposed expansion and it will be met from canal water. Prior permission shall be obtained from the concerned regulatory authority/CGWA in this regard, and renewed from time to time. No ground water recharge shall be permitted within the premises.
- (v). The spent wash shall be concentrated and dried to form DDGS to be used as cattle feed.

- (vi). CO₂ generated from the process shall be bottled/made solid ice and utilized/sold to authorized vendors.
- (vii). Occupational Health Centre for surveillance of the worker's health shall be set up. The health data shall be used in deploying the duties of the workers. All workers & employees shall be provided with required safety kits/mask for personal protection.
- (viii). Training shall be imparted to all employees on safety and health aspects of chemicals handling. Safety and visual reality training shall be provided to employees.
 - (ix). The unit shall make the arrangement for protection of possible fire hazards during manufacturing process in material handling. Firefighting system shall be as per the norms.
 - (x). Process organic residue and spent carbon, if any, shall be sent to Cement other suitable industries for its incinerations. ETP sludge, process inorganic & evaporation salt shall be disposed of to the TSDF.
 - (xi). The company shall undertake waste minimization measures as below (a) Metering and control of quantities of active ingredients to minimize waste;
 (b) Reuse of by-products from the process as raw materials or as raw material substitutes in other processes. (c) Use of automated filling to minimize spillage. (d) Use of Close Feed system into batch reactors. (e) Venting equipment through vapour recovery system. (f) Use of high pressure hoses for equipment clearing to reduce wastewater generation.
- (xii). The green belt of at least 5-10 m width shall be developed in nearly 33% of the total project area, mainly along the plant periphery. Selection of plant species shall be as per the CPCB guidelines in consultation with the State Forest Department. Records of tree canopy shall be monitored through remote sensing map.
- (xiii). As per the Ministry's OM dated 30.09.2020 superseding the OM dated 01.05.2018 regarding the Corporate Environmental Responsibility, and as per the action plan proposed by the project proponent to address the socio-economic and environmental issues in the study area, the project proponent, as committed, shall provide education funds in technical training centers/ support in nearby village's schools, support in health care facilities, drinking water supply and funds for miscellaneous activities

- like solar street lights, battery, solar panel etc., in the nearby villages. The action plan shall be completed within time as proposed.
- (xiv). There shall be adequate space inside the plant premises earmarked for parking of vehicles for raw materials and finished products as per CPCB norms and no parking to be allowed outside on public places.
- (xv). Storage of raw materials shall be either stored in silos or in covered areas to prevent dust pollution and other fugitive emissions.
- (xvi). Continuous online (24x7) monitoring system for stack emissions shall be installed for measurement of flue gas discharge and the pollutants concentration, and the data to be transmitted to the CPCB and SPCB server. For online continuous monitoring of effluent, the unit shall install web camera with night vision capability and flow meters in the channel/drain carrying effluent within the premises.
- (xvii). A separate Environmental Management Cell (having qualified person with Environmental Science/Environmental Engineering/specialization in the project area) equipped with full-fledged laboratory facilities shall be set up to carry out the Environmental Management and Monitoring functions.

B. General Condition:

- (i) No further expansion or modifications in the plant, other than mentioned in the EIA Notification, 2006 and its amendments, shall be carried out without prior approval of the Ministry of Environment, Forest and Climate Change/SEIAA, as applicable. In case of deviations or alterations in the project proposal from those submitted to this Ministry for clearance, a fresh reference shall be made to the Ministry/SEIAA, as applicable, to assess the adequacy of conditions imposed and to add additional environmental protection measures required, if any.
- (ii) The energy source for lighting purpose shall be preferably LED based, or advanced having preference in energy conservation and environment betterment.
- (iii) The overall noise levels in and around the plant area shall be kept well within the standards by providing noise control measures including acoustic hoods, silencers, enclosures etc. on all sources of noise generation. The ambient noise levels shall conform to the standards prescribed under the Environment (Protection) Act, 1986 Rules, 1989 viz. 75 dBA (day time) and 70 dBA (night time).
- (iv) The company shall undertake all relevant measures for improving the socio-economic conditions of the surrounding area. CER activities shall be undertaken by involving local villages and administration and shall be

implemented. The company shall undertake eco-developmental measures including community welfare measures in the project area for the overall improvement of the environment.

- (v) The company shall earmark sufficient funds towards capital cost and recurring cost per annum to implement the conditions stipulated by the Ministry of Environment, Forest and Climate Change as well as the State Government along with the implementation schedule for all the conditions stipulated herein. The funds so earmarked for environment management/pollution control measures shall not be diverted for any other purpose.
- (vi) A copy of the clearance letter shall be sent by the project proponent to concerned Panchayat, Zilla Parishad/Municipal Corporation, Urban local Body and the local NGO, if any, from whom suggestions/ representations, if any, were received while processing the proposal.
- (vii) The project proponent shall also submit six monthly reports on the status of compliance of the stipulated Environmental Clearance conditions including results of monitored data (both in hard copies as well as by email) to the respective Regional Office of MoEF&CC, the respective Zonal Office of CPCB and SPCB. A copy of Environmental Clearance and six monthly compliance status report shall be posted on the website of the company.
- (viii) The environmental statement for each financial year ending 31st March in Form-V as is mandated shall be submitted to the concerned State Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as amended subsequently, shall also be put on the website of the company along with the status of compliance of environmental clearance conditions and shall also be sent to the respective Regional Offices of MoEF&CC by e-mail.
- (ix) The project proponent shall inform the public that the project has been accorded environmental clearance by the Ministry and copies of the clearance letter are available with the SPCB/Committee and may also be seen at Website of the Ministry and at https://parivesh.nic.in/. This shall be advertised within seven days from the date of issue of the clearance letter, at least in two local newspapers that are widely circulated in the region of which one shall be in the vernacular language of the locality concerned and a copy of the same shall be forwarded to the concerned Regional Office of the Ministry.
- (x) The project authorities shall inform the Regional Office as well as the Ministry, the date of financial closure and final approval of the project by the concerned authorities and the date of start of the project.
- (xi) This Environmental clearance is granted subject to final outcome of Hon'ble Supreme Court of India, Hon'ble High Court, Hon'ble NGT and any other Court of Law, if any, as may be applicable to this project.

- **20.** The Ministry reserves the right to stipulate additional conditions, if found necessary at subsequent stages and the project proponent shall implement all the said conditions in a time bound manner. The Ministry may revoke or suspend the environmental clearance, if implementation of any of the above conditions is not found satisfactory.
- **21.** Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of Environment (Protection) Act, 1986.
- **22.** Any appeal against this environmental clearance shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
- **23.** The above conditions will be enforced, inter-alia under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1981, the Environment (Protection) Act, 1986, the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2016 and the Public Liability Insurance Act, 1991 read with subsequent amendments therein.
- **24.** This issue with the approval of the competent authority.

- 1. The industry shall apply for consent of the Board as required under the provision of Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 & Authorization under Hazardous and other Wastes (Management and Transboundary Movement) Rules, 2016, two months before the commissioning of the industry.
- 2. The industry shall provide adequate arrangements for fighting the accidental leakages/ discharge of any air pollutant/gas/liquids from the vessels, mechanical equipments etc. which are likely to cause environmental pollution.
- 3. The Industry shall apply for further extension in the validity of the CTE atleast two months before the expiry of this CTE, if applicable.
- 4. The industry shall comply with any other conditions laid down or directions issued by the Board under the provisions of the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981 from time to time.
- 5. The project has been approved by the Board from pollution angle and the industry shall obtain the approval of site from other concerned departments, if need be.
- 6. The industry shall get its building plans approved under the provisions of section 3-A of Punjab Factory Rules, 1952
- 7. The industry shall put up display board indicating the Environment data in the prescribed format at the main entrance gate
- 8. The industry shall provide port-holes, platforms and/or other necessary facilities as may be required for collecting samples of emissions from any chimney, flue or duct or any other outlets

Specifications of the port-holes shall be as under:

i) The sampling ports shall be provided atleast 8 times chimney diameter downstream and 2 times upstream from the flow disturbance. For a rectangular cross section the equivalent diameter (De) shall be calculated from the following equation to determine upstream, downstream distance:-

- ii) The sampling port shall be 7 to 10 cm in diameter
- 9. The industry shall discharge all gases through a stack of minimum height as specified in the following standards laid down by the Board.

- 10. The industry shall put up canopy on its DG sets and also provide stack of adequate height as per norms prescribed by the Board and shall ensure the compliance of instructions issued by the Board vide office order no. Admin./SA-2/F.No.783/2011/448 dated 8/6/2010.
- 11. The industry shall provide flow meters at the source of water supply, at the outlet of effluent treatment plant and shall maintain the record of the daily reading and submit the same to the concerned Regional Office by the 5th day of the following month.
- 12. The industry shall make necessary arrangements for the monitoring of stack emissions and shall get its emissions analyzed from lab approved / authorized by the Board:-
- (i) Once in Year for Small Scale Industries.
- (ii) Twice/thrice/four time in a Year for Large/Medium Scale Industries
- 13. The pollution control devices shall be interlocked with the manufacturing process of the industry.
- 14. The Board reserves the right to revoke this "consent to establish" (NOC) at any time, in case the industry is found violating any of the conditions of this "consent to establish" and/or the provisions of Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 as amended from time to time

The management has implemented the health and safety policy by adopting following practices.

- 1) It is the Policy of the factory that every responsible effort shall be made to provide and maintain safe and healthy working condition, environment and system of work all employees.
- 2) It shall also be the endeavor of the factory establishment to ensure that surrounding environment is not adversely effected by our work activity.
- 3) The prevention of accidents or accident or accident
- 4) Every employee shall follow safety rules/regulations operating procedures/safe work method design to protect people and equipment from risk or injury or damage to property.
- 5) The factory shall endeavor to adequately train all employees suitably equipped them and instruct them to perform their duties in a safe and effective way by providing first aid training.
- 6) Every employee shall discharge his personal responsibility and shall corporate and actively participate in maintaining and improving safety standards.
- 7) A main policy will be framed in consultation with the workers and the policy will be distributed amongst workers. The health policy will be displayed at prominent place so that every worker is aware of it.
- 8) The doctor will be appointed for health check up of workers at regular intervals and related record shall be maintained.

- 9) Nose masks, refractory boots, hand gloves, fire proximity suit, fire entry suit, water jet blanket, sand scoop, safety helmets, stretcher oxygen breathing apparatus, low temperature protective clothing, low temperature rubbers and gloves, air restarting pump, fire helmets, wind cock indicator, unitized gas director hand/electric siren(m range), fire retardant suit in addition to hose quantity will be provided.
- 10) First aid boxes will be kept ready and easily available to the workers in case of emergencies. Company will provide fastest possible medical aid.
- 11) Adequate supply of clean drinking water, neat and clean toilet and washing facilities will be provided in the factory. Proper ventilation and exhaust fans will be provided in the workshop & main sheds.
- 12) Proper safety & protection, steps and guards will be provided at all required places.
- 13) Firefighting equipment like sand buckets and fire extinguishers will be placed at various locations in the plant.
- 14) Emergency contact numbers will be displayed at the main entrance of the factory.

EQUIPMENT GIVEN TO WORKERS FOR SAFETY & HEALTH

- 1. All safety equipments mention in the health and safety policy are provided.
- 2. Adequate fresh drinking water is supplied to all workers.

FIRST AID TREATMENT

First Aid treatment is given to the effected persons. In case of an accident the following methods shall be adopted by the following persons:

- 1) The Occupier or any of the Directors of the company shall be Chief Coordinator. He will look after the arrangement. One of them shall be always available in the factory during emergency and will arrange the following:
- To shift the victims to the hospital if required
- To arrange vehicles & to bring the persons/experts required to take care of the incident like doctor, etc.
- To get in touch with the civil Hospital/Nursing Home to get prepared to take care of the victims
- To contact with other factories
- To inform the Govt. Authorities
- To liaison with the Govt. Authorities
- They will be assisted by the following officers

Any person from the management of the factory shall contact other Factories, Civil Hospital/Nursing Homes, ESI hospital Police station at Sunder Nagar and also contact with the Manager in charge, Ambulance, Civil Hospital.

The above said person shall be responsible for controlling the disaster, shifting of victims form the spot and provide the victims with First Aid. The Occupier or any of the Directors of the company shall take care of the incident at the site and take all the necessary steps to normalize the situations.






